- 1. Old Business.
 - a. Conference: \$4475 for all the venues, they need half up front. There are tours available for the Sheldon Museum (\$5- 12 to 20 at a time), Marine tour needs 35 people to break even (\$1500), also tour possible for Russian House. Sitka Sound Science center tours also possible weds afternoon. Opening reception needs to be Allen Hall because it is big enough to house everyone and for the 3 min session. Thursday sessions plus breakfast and lunch slots. Catered meals are low cost and a good option because there are few venues. People can add on breakfast & lunch to their tickets. Dinner people would be on their own (except for banquet). We will discuss how we want to include it into registration. Speakers are lunch (Rosita Worl) and dinner (Jim Delgado). Belzoni society will be at Ernie's. Dale Davenport is working on the book room. Rachel Mason is doing the volunteer coordination. Sue Thorson (Sitka) is working on local volunteers. Call for abstracts is December 1-January 15. Registration is usually open right up to the event. Abstract printing cost was \$1500 last year. Abstract submission software fees was approximately \$1000 (Billy is working on this and has promised functionality by December 1). Credit card fees through eventbrite can be passed on to the customer.
 - b. <u>Open Access for Journal:</u> Some of the volumes are on the website. There are issues with the table of contents. Kelly isn't sure how to deal with that.
 - c. <u>Indexing</u>: Shelby waiting to hear about this, will update.

2. New Business

- a. <u>Financial Report:</u> Vivian sent out the profit and loss statement. The last conference lost \$12000. Vanguard lost money through September and that has to be reflected on the P&L. The Journal cost about \$13,000 this year. There was a journal donation but that was actually for color photos. Cash available for the association is \$2785 currently. Total loss last year is \$30,479. After Vanguard is updated we will be back up \$9000. Only \$300 in cash.
- b. <u>Grant Proposal Workshop:</u> Shelby and Jeff Rasic are putting together a grant proposal workshop for the meeting.
